## ***Arbitration***

a form of alternative dispute resolution, is a way to resolve disputes outside the courts. The dispute will be decided by one or more persons, which renders the "arbitral award". An arbitral award is legally binding on both sides and enforceable in the courts.

### **Automobile Insurance Cost Reduction Act of 1998 (AICRA):**

- The act was aimed at lowering insurance rates in New Jersey and also allow for more insurance company competition. As a result New Jersey began to accept basic 'dollar-a-day' (\$15,000/\$30,000 in coverage).
- Mandatory arbitration in personal injury protection (PIP) and no fault benefits cases.

## ***Alternative Dispute Resolution***

ADR procedures can be either mediation (attempting to work the matter out to mutual agreement) or arbitration (a more formal proceeding ending with a decision). An arbitration proceeding operates much like a trial in which witnesses testify and evidence is presented.

- affidavit of permanency is sufficient; in most cases no summary judgement (rare)
